4 Bylaw Amendments Considered

Four amendments to the Bylaws of Single Square Dancers USA, Inc. have been submitted this year and will be considered at the annual meeting of the SSDUSA general membership. There is a deadline of 60 days prior to the annual meeting for written submission of proposals. Each amendment is independent, and is subject to an "up" or "down" vote by the voting delegates at the meeting. If approved, the changes would take effect immediately.


Northwest Region Report

Bylaws Change Proposal #2

Current Reading:

Article VI

Section 2 - Vacancy

A. In the event that any office other than that of President becomes vacant, the office shall be filled by appointment of the Board of Directors. Requirements shall be the same as for election to office.

B. In the event that the Office of the President becomes vacant, the Vice-President shall assume the Office of the President and the Board of Directors shall appoint [as above] a new Vice-President..

Proposed new reading:

A. In the event that any office other than that of President becomes vacant, the office shall be filled by appointment of the Board of Directors. Requirements shall be the same as for election to office.

- 1. In the event that there is no one meeting the requirements stated above, that will accept the position, the Board of Directors may appoint a person that does not meet all the requirements. (for example, a married member or a member who has not been a member for the preceding year.)
- 2. This person will be designated an "Acting Regional Director" or "Acting _____ (name of office)".
- 3. They will perform all the duties of the stated office, but will not be eligible to vote as an officer at board meetings.
- 4. They will wear the normal badge of office, but will have the "Acting" designation in all written material or correspondence.
- 5. A person may be appointed to fill any position as an "Acting Officer" except that of Vice President or President.

Reason for change:

This allows the Board of Directors to appoint the best person for the job, if there are no eligible candidates that will accept the position. For example, a married member may be appointed as "Acting Director" or "Acting Secretary", or if an officer gets married during their term of office, they may be appointed to fill out the remainder of the term as "Acting......".

Bylaws Change Proposal #3

Current Reading:

Article VI

Section 1 – Nominations

E. Any member of the unmarried, individual member, in good standing of the ORGANIZATION for the entire twelve [12] months immediately preceding the annual business meeting of which the member seeks office shall be eligible to stand for nomination, election and or appointment to an office.

Proposed New Reading:

E. Any member of the unmarried, individual member, in good standing of the ORGANIZATION shall

be eligible to stand for nomination, election and or appointment to an office. This person must currently be a member of the ORGANIZATION, and must have been a member for at least 12 months prior to the business meeting.

Reason for change:

This allows for a person that has missed a Dance-A-Rama and left their membership lapse, to become an officer once they have rejoined the ORGANIZATION. The way the current bylaw reads, if a person misses a Dance-A-Rama, and sends in their dues in October, they would not be eligible for office because they were only a member for 11 months immediately preceding the annual business meeting.

Bylaws Change Proposal #4

Current Reading:

Article VIII

Section 6 - Duties of the Treasurer

C. To provide quarterly and annual reports to the Board of Directors as follows: on the first day of December, March, June and at the close of the business year [at the annual business meeting] and such other financial reports as from time to time may be required by the President.

Proposed New Reading:

C. To provide annual reports to the Board of Directors at the close of the business year [at the annual business meeting] and such other financial reports as from time to time may be required by the President.

Reason for change:

The Board of Directors needs the reports whenever a Board meeting is called. This may be quarterly, or only once or twice during the year.

Bylaws Change Proposal # 5

Current Reading:

Article XII

Section 3 – All Bylaw amendment Proposals will be signed.

Proposed New Reading:

Section 3 – All Bylaw amendment Proposals will be signed. Each proposal will include a short paragraph explaining the reason for the change. This explanation does not need to be included in the Intercom printing of the bylaws change.

Reason for change:

This will assist the Board members and the Bylaw Chairperson with understanding the need for this proposal. This will let them know what the proposal is trying to accomplish. Knowing this the Board members or the Bylaw Chairperson may suggest better wording to the proposal, in order to help it get approved.
